## She Was There For Me When No One Else Was

Since 2002, the CAN Council's Court Appointed Special Advocate (CASA) program has been providing a voice for our children who are in the system due to abuse or neglect. Throughout this year, the CAN Council centered its attention on the growth of the CASA program and the critical need for additional CASA volunteers. While recruitment and retention of CASA volunteers is an important focus, the daily commitment of current CASA volunteers can not be taken for granted.



*A young boy was placed with his grandmother when it became unsafe for him to continue living with his mother due to domestic violence. Having gone through many struggles and traumatic events in his life, he isolated himself, played video games, and hardly acknowledged when people came to visit him. When his CASA started visiting, he would sit and stare at his video game, rarely responding to her questions. It seemed like everyone who came into his life had always left, and he never had anyone that would stay.*

*After getting to know his CASA, he slowly came out of his shell, playing board games and working on homework with her. He now talks about his CASA being someone he could count on because for months, she kept coming back and was there for him when it seemed like no one else was.*

Would you like to be a powerful advocate in the life of a child that is in our court system due to abuse and neglect? You CAN! The next training series begins Monday, October 29th at 5:30pm – 9pm at the CAN Council Great Lakes Bay Region – Saginaw County office. The CASA movement began in 1977, when a Seattle juvenile court judge concerned about making drastic decisions with insufficient information conceived the idea of citizen volunteers speaking up for the best interests of abused and neglected children in the courtroom.

### PRESIDENT'S POINT OF VIEW

In the last month, as part of the fourth cohort educated in Michigan, I was trained as a Master Trainer for the ACEs' curriculum by the Michigan ACE Initiative by one of the researchers. For two full days, I was in a room with physicians, child psychiatrists, educators, educational administrators, teachers, and human resource professionals. This information will transform the way we interact with children!



In the coming months, you'll hear more about Adverse Childhood Experiences (ACEs). This research shows that we need to talk directly with all people (especially children) and not ask, "What's wrong with you?" but rather "What happened to you?". ACEs is the largest public health discovery of our time and it's about the smallest among us. The effects of childhood trauma impact my work every day at the CAN Council, as well as in the collaborative efforts throughout our region. One of the most critical factors in a child's growth is whether or not they are exposed repeatedly to ACEs, which include abuse, neglect, and other factors including family substance use and the incarceration of a parent. Without protective resources in times of need, like support from adults, trauma can trigger the release of stress hormones which impede the growth of brain regions that regulate behavior. Studies show that the more ACEs a young person encounters, the more barriers to achieving positive life outcomes they face. One way that we are working to provide these protective factors is through our Parenting Support and Education programs which are evidence-based and available at no cost to all parents in our region. We are working daily to strengthen these programs so they are available for any and all parents!

This study will change the way that we move forward in our schools, medical offices, child care centers, and so much more! There will be trainings offered throughout our region, so please keep an eye out on our website and Facebook for more information!

As always, I welcome the opportunity to meet with you and share your ideas for protecting our children. You make it possible to work toward our mission daily! 

On August 29th, 30 Forensic Interviewers from throughout Michigan came for a full day of specialized training on interviewing victims of child pornography and technology-facilitated abuse. Presented by FBI Forensic Interviewer Catherine S. Connell, this training focused on how to get an accurate testimony without further traumatizing the victim, the child. While abusers often use technology to maintain control over victims, many people don't know what constitutes digital abuse and are not able to recognize the signs.



## From Victim to Victorious

Six years ago, **Dashun Jackson** was a boy in need of a voice. After years of abuse at the hands of his mother and her boyfriend, he had many physical and emotional scars, including what he describes as an inability to talk with men.



*"As a boy, my three sisters and I suffered just about every form of abuse you can imagine— emotional and physical attacks by my mother, later sexual abuse by her and her boyfriend. When I was 13 years old, we were all removed from our home. After that, I bounced around, from a children's emergency shelter to an aunt's house, then back to the shelter. There was so much I did not know about the foster care system. Without knowledge or the power to speak up, I felt like a victim.*

*"A year and a half later, I met my CASA volunteer, Robert. And everything changed. Robert taught me how to communicate, how to represent myself and my needs. He helped me understand what was happening in court and taught me how to stand up for myself.*

*"When I had something to say, Robert made sure my voice was heard. When I did not want to or could not speak, he spoke for me.*

*"At every school event, Robert was there. From ROTC ceremonies to my high school graduation, he was there. When I took hold of my diploma, I heard his cheers above the rest.*

*"About that same time, I was placed into my final foster home, where I learned about service to others. My foster father did so much more than he had to do, for me and for those around him. From that moment on I decided that there was much that I need to give back."*

## Car Seat Safety Tips

The best way to keep your child safe in the car is to use the right car seat in the right way. Here are some fast facts about car seat safety and a few tips to protect your most precious cargo.

### Hard Facts about Safety in Cars

- Road injuries are the leading cause of preventable deaths and injuries to children in the United States.
- Correctly used child safety seats can reduce the risk of death by as much as 71 percent.
- Three out of four car seats are not used or installed correctly.

### Top Tips about Car Seat Safety

**Buying the right car seat.** Your baby needs to ride in a rear-facing car seat as long as possible, at least until age 2. When your child has outgrown that seat, you are ready for a forward-facing car seat.

**Installing your car seat.** You'll need to decide on using either the seat belt or lower anchors to secure your car seat. Both are safe, but don't use them both at the same time. Once your child is forward facing, it is important to use the tether with the seat belt or lower anchors.

**Getting the right fit.** A properly-fitted harness gives the best possible protection for your child.

**When to change your car seat.** Look on the car seat label to make sure your child is still within the weight, height, and age limits for that seat.



### Time to Move to the Next Type of Car Seat?

**Don't be in a rush.** Use your current car seat until your child reaches the maximum weight or height limit listed on the label. Don't be in a hurry, because every step forward reduces safety just a bit. Why? If you are in a front-end crash (the most common type of crash) a rear-facing car seat allows your child's head, neck and spine to move evenly into the seat, not away from it. Each seat is designed for maximum safety at a specific weight, height, and age.

**Rear-facing car seats.** Ride rear-facing until your child is at least 2 years old. As your child grows you might have to switch from using a smaller rear-facing-only car seat to using a bigger rear-facing convertible car seat that can hold a larger child.

**Forward-facing car seats.** After your child reaches the weight limit for rear-facing, you will then turn the convertible seat forward-facing, or use a forward-facing only car seat with a 5-point harness and top tether. Your child may need a forward-facing car seat with a harness that has a higher weight or height limit before moving to a booster seat.



**Booster seats.** After your child gets too big for the weight or height limits of the forward-facing car seat, use a belt-positioning booster seat with the vehicle lap and shoulder seat belt.
