## PRESIDENT'S POINT OF VIEW

With summer upon us and the Great Lakes Bay Region alive with activity, we have completed our events honoring April's *Child Abuse Prevention Month* and the community's support was at an all-time high! You may have noticed the playful blue and silver pinwheels throughout Bay and Saginaw counties. In fact, we are so proud that you helped us plant over 8,000 symbols of a happy, healthy, and safe childhood that all children deserve!



As May moved along, we took on several exciting projects that are moving us closer to *"building communities where children are free from abuse and neglect"*! Here are just a couple of items you will read about in this newsletter:

- **Child Abuse Prevention Education:** Through our partnership with the Michigan Children's Trust Fund, we were awarded a grant to provide multiple classes of our *Make Parenting A Pleasure* evidence-based curriculum and partner with area organizations to meet the needs of our parents – such as YMCA (exercise/health), MSU Extension (nutrition), and so much more. Next, our Prevention Education Director, Vera Harrison, and her team were asked to coordinate the selection and distribution of parenting curriculum and materials that would be made available to ALL of the 72 local councils in the state of Michigan! This is a rare opportunity for all of the local councils to expand their resources and provide/expand parenting education and support! Way to go CAPE Team!
- **Court Appointed Special Advocates (CASA):** Although we are always recruiting CASA volunteers, we have had a special effort to attract new volunteers that will become the voice for our children in foster care due to abuse and/or neglect. Each day, we all are working, together with you, to stop child abuse and neglect in our region. ## Critical Call to Action

The CAN Council Great Lakes Bay Region is working to stop child abuse and neglect here in your community through innovative programming, comprehensive services, and effective collaborations.

One program that helps the CAN Council achieve their mission of "building communities where children are free from abuse and neglect" is the Court Appointed Special Advocate (CASA) program. CASAs volunteer their time to advocate for foster children who are in the court system due to abuse or neglect. The CAN Council provides nationally-accredited training to CASA volunteers that are appointed by family court judges to serve as a voice for the child; providing support and solace to children who are entangled in the system.



CASAs are the children's lighthouse when they cannot see through the storm... their voice when they are lost in the fold... their source of stability during a confusing time that no child should ever have to endure.

## Make Parenting A Pleasure



Being a parent is one of the most difficult, challenging, and rewarding experiences that life offers. It is an awesome responsibility to raise a child who will become a healthy, well-functioning person to take his or her place in the next generation. The future of the world lies in the hands of people our children will become.

The CAN Council Great Lakes Bay Region's *Make Parenting a Pleasure* is a collaborative parenting series focused on parents with children aged 0 – 8 years old. This enhanced, 16-week parenting series will give parents the tools to help their children succeed, and will also offer support to the parents who attend the course.

A new class will begin on Monday, June 5th and will be open to the first 12 parents who register; enrollment is on a first-come, first-serve basis. Your 16-week session will feature activities with community partners such as **Wildfire Credit Union, U Me Paint, Mid-Michigan Children's Museum, Department of Health and Human Services, Saginaw YMCA, Covenant HealthCare, and Michigan State Extension.** Weekly topics include nurturing, self-care, understanding stress, managing anger, communication and listening skills, child development, and alternatives in discipline.
