Ready to change a child's life? CASA Highlights

Every abused or neglected child needs a caring, consistent adult to advocate for his or her well-being. A Court Appointed Special Advocate (CASA) is a volunteer who devotes time to advocate for foster children who are in the court system due to abuse or neglect. The CASA is a source of stability and solace to children during a confusing time that no child should ever have to endure.

What Do CASA Volunteers Do?

CASA volunteers listen first. Then they act. Volunteers get to know the child by talking with everyone in that child's life: parents and relatives, foster parents, teachers, medical professionals, attorneys, social workers, and others. They use the information they gather to inform judges and others of what the child needs and what will be the best permanent home for them.

Who Can Be a Volunteer?

You do not have to be a lawyer or a social worker to be a volunteer. We welcome people from all walks of life. We are simply looking for people who care about children and have common sense. As a volunteer, you will be thoroughly trained and well supported by professional staff to help you through each case.

What does it take to be a CASA?

National standards require that you must be 21 years of age, pass an extensive background check, have a high school diploma or GED, strong written and verbal communication skills, participate in a 40-hour preservice training, and have the flexibility in your schedule to advocate for children you're assigned. The CAN Council provides this nationally-accredited training to CASA volunteers, who will then be appointed by a family court judge to serve as a voice for the child. It's most helpful to the child if you make weekly visits and stay with a case until it is closed (an average of 1.5 years).



Nobody longs for a safe and loving family more than a child in foster care. As a CASA volunteer, you are empowered by the courts to help make this dream a reality. You will not only bring positive change to the lives of these vulnerable children, but also their children and generations to come.

Kids Arrive Safely

Safe transportation is a necessity for small children. Recognizing the need, the CAN Council was able to obtain the *Kids Arrive Safely* grant through the United Way of Bay County to help eligible families get age-appropriate car seats.

Kids Arrive Safely requires an assessment be completed on all referrals to determine a family's eligibility. To receive a car seat, the parent or caregiver must be within 133% of the Federal Poverty Level. Once approved, they will be given the date of the next installation day that they are required to attend. A \$10 co-pay per seat is required. If it is determined that the co-pay is a barrier to receiving the car seat, the fee is reduced or waived for the family. There is also a telephone survey conducted 30-60 days post-installation to ensure the parent is using the seat properly and to answer any questions they may have.



Leslie Eschenbacher, CAN Council's Prevention Education Coordinator, and now Child Passenger Safety Technician, will instruct the caregiver on how to install each car seat and provide applicable safety education. She shares, "We want all children traveling safely. This one-on-one learning experience insures the caregiver leaves feeling confident that the child's seat is installed correctly, and that they feel comfortable reinstalling it on their own. Helping them to understand all they can do to prevent unintentional injuries in and around cars is one the most important things to learn."

Baby Academy

Parenting is tough stuff! In collaboration with Covenant HealthCare, Great Lakes Bav Health Centers, and Saginaw Public School District's Birth-5 **Program**, the CAN Council's 5th Annual Baby Academy offered a variety of helpful child-rearing



resources all in one place. From products to services, over 70 participants were able to peruse vendor booths offering a variety of goods for children and families. A special thanks to the 23 community partner agencies that provided pertinent information and free baby-friendly items including 60 diapers per month, per child for each parent in attendance.

Attendees were able to take part in breakout sessions including Breastfeeding, Early Literacy, Five Protective Factors, Infant CPR, Nutrition/Food Demonstrations, Safe Sleep, Simply Dads, and Yoga. During these sessions, parents and family members received invaluable insight on parenting topics and information on how to be the best parent or caregiver possible.

Expectant parents and parents with babies up to 1 year old were invited to attend, as were grandparents and other key support persons. Childcare professionals were also encouraged to join the fun. **Dr. Erica** Canales, Assistant Program Director of CMU's Department of OB/GYN, was the keynote speaker focusing on their CenteringPregnancy Program.

The CAN Council extends its gratitude to St. Mary's of Michigan Health Education Center for hosting the event, as well as former board member Karen Stiffler, who secured the venue.

Sponsors who helped celebrate were St. Mary's of Michigan, Great Lakes Bay Medical Centers, and Molina Healthcare. Molina Healthcare held drawings for a car seat, Babies "R" Us gift cards, and baby hygiene items. Safe Kids Michigan also gave away a car seat.

The community's contribution made it possible for parents to learn about the numerous resources available throughout the Great Lakes Bay Region that they may not have previously known. Par-Tee One Last Time



Legacy Giving


Did you know that you can put the CAN Council in your will or trust?

Planned giving is when a person decides to give at some future date, either a number of years from now or at death. A planned gift is a present decision to make a future gift, often evidenced by a legal document such as a will or trust.

Charitable gifts, either current or future, often have state/federal income tax, capital gains, and estate and gift benefits associated with them. To maximize these benefits, consulting with a legal/tax advisor is advised.

One of the easiest ways to implement planned giving is to incorporate language into your estate (will or trust) planning documents. An example of such language is: "I hereby give, devise and bequest [\$Dollars] to CAN Council Great Lakes Bay Region, a non-profit organization located at 1311 N. Michigan Avenue, Saginaw, MI 48602 (Federal Tax ID: 38-2480726), for its general use and purposes," (please request additional language for Bay County).
