# **Preserving the Wonder of Childhood**

In 2017, for the first time ever, we received a three year grant from the Children's Trust Fund to conduct a collaborative parenting support and education program whose focus is to prevent child abuse and neglect. With years of planning and tireless dedication of our prevention team, we have made what was once a vision – a reality.

Make Parenting A Pleasure (MPAP) is a program currently being provided in Saginaw, Bay, and Arenac Counties. MPAP is a 12-week, evidence-based parenting curriculum which we enhance based on our parent's needs. Each program may last up to 16 weeks as we add requested components. For example, some of our parents speak



of needing financial literacy education so we partner with local financial institutions to provide this during one week. The following week, we may partner with a local nutrition expert to teach our parents about good nutrition and how to cook healthy meals on a budget. The bottom line is that we were awarded this grant in partnership with local businesses and non-profits to provide the best possible program for our community's parents.



This enhanced parenting program has proven to be a success as illustrated by the fact that the national average for retention in parenting education classes is approximately 50%. In the last four years, our average retention has been 87%! With the expansion of this program to Bay and Arenac Counties, we have secured

additional funding to train additional facilitators. For more information, call one of our offices.

# **Comfort Canine for Families**

The CAN Council's Children's Advocacy Centers (CACs) will soon hear the pitter-patter of little paws around the office, thanks to **Brenda Haines**. Brenda had reached out through the CAN Council's website, asking if there was any interest in working with her therapy dog, **Jake**, a golden retriever. Jake is a graduate of the American Kennel Club's 12-week program, which included six weeks of obedience training and a six-week internship in public places designed to test obedience and discipline for the trainer and dog alike.



Open to ideas and suggestions on how to better serve families that visit, the CAN Council soon scheduled a meeting to discuss the various opportunities. After meeting, it was clear that Jake would be a great asset to the CAC program. Comfort and therapy dogs are used at CACs throughout the nation to assist children with traumatic experiences they may be facing.

Jake will be present on scheduled days to meet the children and families before and after the interviews, if requested by the families. The hope is that his presence will calm the children as they potentially disclose being sexually, physically, or emotionally abused or neglected, or if they have witnessed violence, and will help the caregivers cope with such trauma. The CAN Council's CAC Care Coordinators

will communicate with the families prior to the interviews, to be certain Jake would be welcomed to the interview.

With a heart of gold, Brenda is offering this service at no cost, in hopes of giving back to the community and those in need. A special thanks to Brenda and to Jake, as the CAN Council looks forward to working with you in this new adventure!

# **National Crime Victims' Rights Week**

# A Cause with a First and Last Name

A Court Appointed Special Advocate (CASA) is a selfless volunteer who devotes their time to representing the best interest of children placed into the foster care system due to abuse and neglect. These volunteers are appointed by a judge to advocate for a child, assuring that their voices don't get lost in the overwhelming legal and social service system. For many children, their CASA volunteer will be the one constant adult in their lives.

Established in 2002, Saginaw County's CASA program was the first in the state of Michigan to be accredited by the National CASA Association. By 2015, the program expanded into Bay County. This is great news for our children because according to the National CASA Association, around 12% of children in foster care return to care within six months. For children with a CASA volunteer, their likelihood to return to foster care is 5%. To date, Saginaw and Bay Counties have served nearly 1,100 children.

CASAs are needed to fulfill our mission. During the latest Swearing-In Ceremony, five new CASA volunteers have been trained and appointed including **Debra Barnes**, **Colleen Bryant**, **Doris Johnson**, **Monica Medel**, and **Connie Parkhurst**. Without their dedication to our youth, our children's voices would be lost.

While expanding CASA training to include Fostering Futures (a national program through National CASA to assist in preparing our teens to successfully transition out of the foster care system), the CAN Council has also continued to recruit, train, and assign new CASAs. In 2017, 156 children were served, but there are more children in foster care who go unserved as we need additional CASA volunteers. You CAN be the voice for a child! # The Starfish (adapted from "The Star Thrower" by Loren Eisely)

Approaching the boy, he asked, "What are you doing?" The boy replied, "Throwing a starfish into the ocean. The sun is up and the tide is going out. If I don't throw them back, they'll die."

"Son," the man said, "don't you realize there are miles and miles of beach and hundreds of starfish? You can't possibly make a difference!"

After listening politely, the boy bent down, picked up another starfish, and threw it into the surf. Then, smiling at the man, he said, *"I made a difference for that one."* 



# **Swimming Safety**

#### **Hard Facts**

- Among preventable injuries, drowning is the leading cause of death for children 1–4 years old.
- Children 1–4 years old are more likely to drown in a pool.
- Children 5 years and older are more likely to drown in natural water, such as ponds, lakes and rivers.
- The risk of drowning in open water increases with age: The average 10-year-old, for example, is three times more likely to drown in open water than in a pool.

## **Top Tips**

- Watch kids when they are in or around water, without being distracted. Keep young children within arm's reach of an adult. Make sure older children swim with a partner every time.
- Teach children how to swim. Every child is different, so enroll children in swim lessons when they are ready. Consider their age, development and how often they are around water when deciding if they are ready for swim lessons.
- Make sure kids learn these five water survival skills and that they are able to:
  - step or jump into water over their heads and return to the surface;
  - float or tread water for one minute;
  - turn around in a full circle and find an exit;
  - swim 25 yards to exit the water; and
  - exit the water. If in a pool, be able to exit without using the ladder.
- Teach children that swimming in open water is not the same as swimming in a pool. They need to be aware of uneven surfaces, river currents, ocean undertow and changing weather.
- Know what to do in an emergency. Learning CPR and basic water rescue skills may help you save a child's life.

# **Preventing Heatstroke**

Sometimes babies are so peaceful and quiet in the backseat that we can forget they are even there, and it can be tempting to leave a sleeping baby in the car so we don't have to wake them up while we quickly run into the store. But leaving a child alone in a car can lead to serious injury or death from heatstroke, even in cooler temperatures.

# **Hard Facts**

- On average, a child dies from heatstroke in a vehicle every 10 days. In more than half of these deaths, the caregiver forgot the child was in the car.
- A car can heat up 19 degrees in just 10 minutes. Cracking windows doesn't help.
- Young children are particularly at risk, as their bodies heat up three to five times faster than an adult's.

# Reduce the number of deaths from heatstroke by remembering to ACT.

- Avoid heatstroke-related injury and death by never leaving a child alone in a car, not even for a minute. And make sure to keep your car locked when you're not inside so kids don't get in on their own.
- Create reminders. Keep a stuffed animal or other memento in your child's car seat when it's empty, and move it to the front seat as a visual reminder when your child is in the back seat or place and secure your phone, briefcase, or purse in the back seat when traveling with your child.
- *Take action*. If you see a child alone in a car, call 911. Emergency personnel want you to call. They're trained to respond to this.
